CLÁUSULA PRIMEIRA – OBJETO DO ADITAMENTO

1.1. No preâmbulo do Contrato de Gestão, onde se lê: “com dispensa de chamamento público, com fundamento no artigo 24, inciso IV c/c XXIV, leia-se “com a realização de Chamamento Público, publicado no Diário Oficial da Cidade no dia 11 de setembro de 2020.”

1.2. Fica estabelecida a redução da Meta 14.1: Percentual de captação (receitas operacionais, outras receitas não incentivadas e recursos incentivados) sobre o total do orçamento anual de 10% (dez por cento) para 3,6% (três vírgula seis por cento) exclusivamente para o exercício de 2021, retornando as metas estabelecidas no contrato para o exercício de 2022, diante das justificativas apresentadas por meio do Ofício 173/2021.

1.3. Fica estabelecida a correção da cláusula 2.1.47 para que conste o prazo de 18 (dezoito) meses para realizar as adequações já aprovadas pelo Corpo de Bombeiros, de forma a obter o AVCB para o edifício do Theatro Municipal, a partir da assinatura do contrato, prorrogáveis mediante justificativa a ser submetida à aprovação da Contratante.

2.1. Os demais termos e condições do Contrato de Gestão nº02/FTMSP/2021 que não foram expressamente alterados pelo presente aditivo permanecem em pleno vigor, sendo ratificados pelas partes.





ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Sustenidos Organização Social de Cultura (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
